

## FOOD RHEOLOGY AND TEXTURE

### Summary

Rheology is the study of the deformation and flow of all matter. Fluid foods that contain relatively small molecules exhibit Newtonian behavior, while those containing dissolved polymers, insoluble solids, or immiscible fluids exhibit non-Newtonian flow behavior. The power law model has been used extensively to characterize non-Newtonian fluid foods. Links between viscosity, and structure and sensory stimuli, as well as in handling operations, have been established. Small amplitude oscillatory tests are being used to study the characteristics of food gels, sol-gel, and gel-sol transition. Texture represents a group of mechanical or rheological properties. Texture tests based on puncture, compression, elongation, and extrusion are being used.

### 1. Introduction

By definition, rheology is the deformation and flow of matter. Rheological studies on liquid and solid foods are conducted using test geometries that are amenable to mathematical analysis of the applied strain and strain rate, and the resulting linear or nonlinear stress. Results obtained from many rheological studies on fluid and solid foods have been interpreted in terms of either the characteristics of the molecules of biopolymer dispersions or the microstructure or composition of multi-component foods. In many instances, as in the viscosity of food suspensions and viscoelastic properties of gels, and the effect of temperature on the viscosity of fluid foods, the results of pioneering studies by distinguished scientists, such as Acrivos, Arrhenius, Flory, de Gennes, and Krieger are applicable (see *Newtonian and Non-Newtonian Flow, Viscoelasticity*).

There are numerous definitions for food texture, many of which are commodity-oriented and others that are feel-oriented, but it is generally recognized that texture represents a group of physical properties that are often mechanical or rheological. Texture profile analysis (TPA) has emerged as one manner of understanding the results obtained from texture tests, and several characteristics of foods have been introduced. For example, rigidity, which comes very close to being the classical elastic modulus, is one such

parameter (see *Solid Foods, Texture in Solid and Semi-Solid Foods*).

The various topics in Food Rheology and Texture that follow cover several important subjects which are useful in better understanding the role of composition and structure on rheological behavior; also included are up-to-date measurement techniques. Because many fluid foods exhibit either Newtonian or non-Newtonian behavior, one of the articles is on Newtonian and non-Newtonian flow. The non-Newtonian behavior is due to either dissolved polymers (guar gum, xanthan gum, pectins, amylose, proteins) and/or due to the dispersed nature of the food where the dispersed phase may be made up of insoluble solids (as in suspensions) or an immiscible fluid (as in emulsions). Due to their unique nature, the rheological behavior of emulsions and suspensions are best studied separately.

In food rheology, many widely applicable models have been developed to fit shear rate ( $\dot{\gamma}$ ,  $s^{-1}$ ) versus shear stress ( $\sigma$ , Pa), and to describe the effect of temperature on the rheological data of fluid foods. For example, the applicability of the power law model (Equation 1) to many fluid foods over ranges of shear rates (10-150  $s^{-1}$ ), useful in many practical applications, and that of the Arrhenius equation for quantitatively describing the effect of temperature on the viscosity (Equation 2), or the consistency index of the power law model (Equation 3), have been well documented.

$$\sigma = K \dot{\gamma}^n \quad (1)$$

$$\eta = \eta_{\infty} \exp (E_a / RT) \quad (2)$$

$$K = K_{\infty} \exp (E_a / RT) \quad (3)$$

Compilations of values of the power law parameters and the Arrhenius activation energies can be found in several of the references listed in the Bibliography. A number of other useful flow models (e.g., the Casson model used for characterizing chocolate) and functional models (e.g., Krieger-Dougherty model for the influence of suspended solids and the Williams-Landel-Ferry model for the effect of temperature) are available for obtaining information on fluid foods and correlating their rheological behavior, and they have been reviewed elsewhere.

Many food polymers occur naturally in plants and animals, and a few are also obtained by fermentation (e.g., xanthan gum). Most, if not all, are soluble in water and are called food gums or food hydrocolloids. Food hydrocolloids play many important roles, such as imparting desirable viscosity, yield stress, and ice crystal formation. The relationship between the viscosity and the molecular size of several carbohydrate polymers has been studied. Specifically, the viscosity  $\eta_{sp} = \left( \frac{\eta_0 - \eta_s}{\eta_s} \right)$ , based on the constant viscosity at

low shear rates of the dispersions of several carbohydrate polymers, called the zero-shear or Newtonian viscosity ( $\eta_0$ ), was related to the product of concentration ( $c$ ) and intrinsic viscosity, called the coil-overlap parameter ( $c[\eta]$ );  $\eta_s$  is the viscosity of the

solvent (water). The coil-overlap parameter reflects the degree of occupancy of space by the food polymer coils. Separate correlations were found for the dilute region ( $c[\eta]$  up to about 4) with a slope of 1.4 and for the concentrated region with a slope of 3.3 (Figure 1). Because the intrinsic viscosity of a biopolymer is closely associated with its molecular weight ( $M$ ) via the Mark-Houwink equation (Equation 4), the link between viscosity and molecular weight should be recognized.

$$[\eta] = K_{MH} (M)^a \quad (4)$$

where  $K_{MH}$  and  $a$  are empirical coefficients. One important use of the relationship in Figure 1 is that it can be used to estimate the zero-shear viscosity of the dispersion of a food polymer when the polymer concentration and intrinsic viscosity are known. In addition, exponential and power law models can be used to describe the influence of soluble (e.g., °Brix) and insoluble solids (e.g., the pulp content of fruit juices) on the viscosity of processed foods (e.g., fruit juices and purees).

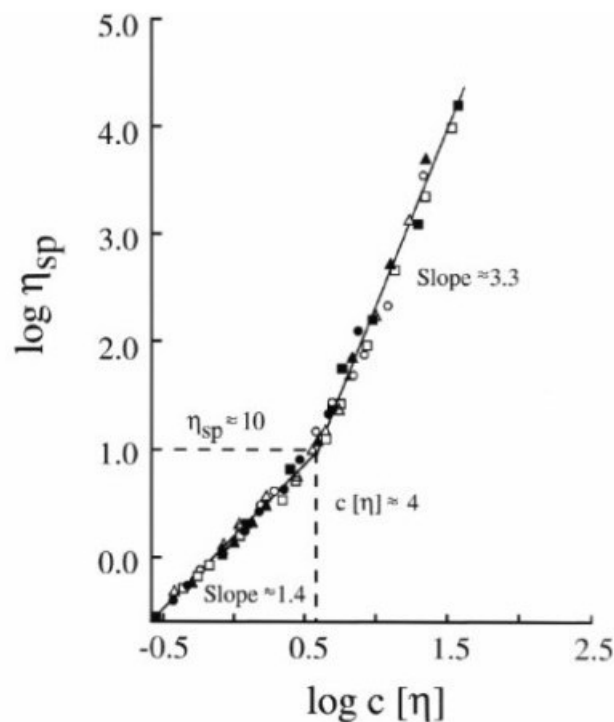


Figure 1. Variation of specific viscosity based on the zero-shear (Newtonian) viscosity of biopolymer dispersions with the coil-overlap parameter: ○ dextran; ◌ carboxymethylamylose (0.5M NaCl, pH7); △ high mannuronate alginate (0.2M NaCl, pH7); ▲ high guluronate alginate (0.2M NaCl, pH7); ◆ (hyaluronate (0.015M NaCl; pH7); ◻ lambda carrageenan (0.075 M KCl; pH7).

Texture Studies* **13**, 115-126. [This paper showed that heated starch granules expand after gelatinization, and that the expansion contributes to increase in viscosity].

Bourne M.C. (1982). *Food Texture and Viscosity: Concept and Measurement*. New York: Academic Press. [This book deals primarily with food texture and its measurement, including instrumental texture profile analysis].

Campanella O.H., Popplewell L.M., Rosenau J.R., and Peleg M. (1987). Elongational viscosity measurements of melting American process cheese. *J. Food Sci.* **52**, 1249-1251. [This paper describes the measurement of elongational viscosity of foods, especially of American processed cheese].

Casiraghi E.M., Bagley E.B., and Christianson D.D. (1985). Behavior of mozzarella, cheddar and processed cheese spread in lubricated and bonded uniaxial compression. *J. Texture Studies* **16**, 281-301. [This publication pointed out that the friction between some foods and the platen of a Universal Testing Machine affects the values of texture parameters, and offers suggestions as to how to minimize the effects].

Chamberlain E.K., Rao M.A., and Cohen C. (1999). Shear thinning and anti-thixotropic behavior of a heated cross-linked waxy maize starch dispersion. *J. Food Properties* **2**, 63-77; errata, **2**, 195-196. [This paper points out the important role of starch granule surface morphology on rheological behavior of heated cross-linked, waxy maize starch dispersions].

Chatraei S.H., Macosko C.W., and Winter H.H. (1981). A new biaxial extensional rheometer. *J. Rheol.* **25**, 433-443. [In this paper, a technique was developed to measure biaxial extensional viscosity using a Universal Testing Machine].

Cussler E.L., Kokini J.L., Weinheimer R.L., and Moskowitz H.R. (1979). Food texture in the mouth. *Food Technol.* **33**(10): 89-92. [This paper confirmed Shama and Sherman's observations on the oral perception of viscosity].

Cutler A.N., Morris E.R., and Taylor L.J. (1983). Oral perception of viscosity in fluid foods and model systems. *J. Texture Studies* **14**, 377-395. [This paper describes the correlation developed between complex dynamic viscosity and the oral perception of viscosity].

Fu J-T. and Rao M.A. (1999). The influence of sucrose and sorbitol on gel-sol transition of low-methoxyl pectin +  $Ca^{2+}$  gels. *Food Hydrocolloids* **13**, 371-380. [This paper deals with the relationship between gel melting temperature and concentration of the polymer (low-methoxyl pectin)].

Holdsworth S.D. (1993). Rheological models used for the prediction of the flow properties of food products: a literature review. *Trans. Institution of Chem. Engineers* **71**, Part C: 139-179. [This paper has an extensive collection of rheological models and literature values of their parameters].

Liao H.-J., Tattiyakul J., and Rao M.A. (1999). Superposition of complex viscosity curves during gelatinization of starch dispersion and dough. *J. Food Process Eng.* **22**, 215-234. [In this paper, it was shown that the viscosity data on dough or starch dispersion during heating at several shear rates (thermorheological behavior) could be reduced to a single curve by superposition].

Morris E.R., Cutler A.N., Ross-Murphy S.B., and Rees D.A. (1981). Concentration and shear rate dependence of viscosity in random coil polysaccharide solutions. *Carbohydrate Polymers* **1**, 5-21. [The role of the molecular size of random coil polymer, as indicated by intrinsic viscosity; concentration is shown to be the same for several polymers].

Okechukwu P.E. and Rao M.A. (1996). Kinetics of cornstarch granule swelling in excess water, in *Gums & Stabilisers for The Food Industry* (eds. G.O. Phillips, P.A. Williams, and D.J. Wedlock), 49-57. Oxford, U.K: The Oxford University Press. [The unique characteristics of swollen cornstarch granule diameters, heated for different times and at various temperatures, are discussed].

Padmanabhan M. (1995). Measurement of extensional viscosity of viscoelastic liquid foods. *J. Food Eng.* **25**, 311-327. [The different techniques used to measure extensional viscosity of liquid foods are reviewed].

Peleg M. (1980). Linearization of relaxation and creep curves of solid biological materials. *J. Rheol.* **24**, 451-463. [An empirical expression was developed to describe data obtained in relaxation and creep tests].

Rao M.A. (1999). *Rheology of Fluid and Semisolid Foods: Principles and Applications*, 433 pp. Gaithersburg, MD: Aspen Publishers, Inc. [This book covers the basic principles of rheology: models to describe rheological data, measurement of rheological properties, literature values of rheological properties of foods, rheological behavior of food dispersions and gels, sensory assessment of viscosity of foods, as well as the role of rheology in pumping, mixing, and heat transfer].

Shama F., Parkinson C., and Sherman P. (1973). Identification of stimuli controlling the sensory evaluation of viscosity. I. Non-oral methods. *J. Texture Studies* **4**, 102-110. [This paper compares the relationship between viscosity data, in fundamental units, and the non-oral evaluation of viscosity by a panel during the stirring and tilting of a container].

Shama F. and Sherman P. (1973). Identification of stimuli controlling the sensory evaluation of viscosity. II. Oral methods. *J. Texture Studies* **4**, 111-118. [This paper compares the relationship between viscosity data, in fundamental units, and that evaluated orally by a panel. Later studies confirmed the results of this study].

Simpson S.G. and Williams M.C. (1974). An analysis of high temperature/short time sterilization during laminar flow. *J. Food Sci.* **39**, 1047-1054. [The authors showed how the combined effect of shear and temperature (thermorheological behavior) of fluid foods affects the design of a continuous sterilizer].

Tattiyakul J. (2001). Thermorheology and Heat Transfer to a Canned Starch Dispersion Under Agitation: Numerical Simulation and Experiment. Ph.D. thesis. Ithaca, NY: Cornell University. [The author showed that the single viscosity-shear rate-temperature curve of a starch dispersion obtained by superposition (thermorheological behavior) can be used in the computer simulation of heat transfer to the dispersion in a rotating can, and showed that the predicted results agree well with experimental data].

Tobitani A. and Ross-Murphy S.B. (1997). Heat-induced gelation of globular proteins. 1. Model for the effects of time and temperature on the gelation time of BSA. *Macromolecules* **30**, 4845-4854. [The relationship between the gel time of the protein bovine serum albumin on the one hand, and its concentration on the other, was established].

Yang W.H. (1997). Rheological behavior and heat transfer to a canned starch dispersion: computer simulation and experiment. Ph.D. thesis. Ithaca, NY: Cornell University. [The author established the experimental and data-analysis techniques to correlate viscosity data obtained during heating of a corn starch dispersion at different shear rates (thermorheological behavior), and developed numerical techniques for sterilization of the dispersion in a stationary can].

Yang W.H. and Rao M.A. (1998). Numerical study of parameters affecting broken heating curve. *J. Food Engineering* **37**, 43-61. [The author showed the relationship between thermorheological data of a food containing starch and broken heating phenomena encountered during food sterilization of such foods].

### **Biographical Sketch**

**M. A. "Andy" Rao** is a Professor of Food Engineering at the Geneva, NY campus of Cornell University. His research focus is on the measurement and interpretation of viscous and viscoelastic properties of fluid foods, thermal processing of solid and liquid foods, and unit operations in the preservation of fruit and vegetable products. Many original review papers and book chapters by Rao and his co-workers have resulted from these studies, including the book: Rao, M. A.
